Cancellation or Early Termination

Either party may terminate this Contract a minimum 3 (three) days prior to the FIRST scheduled visit without incurring penalties.

Cancellation by the Owner of scheduled sessions with less than 3 days notice may be charged at the full rate or rescheduled at Pets Assist Ltd discretion

Should any pet(s) become aggressive or dangerous, Pets Assist Ltd may terminate this contract with immediate effect, where pre-paid payments have already been made any refund will be at the discretion of Pets Assist Ltd.

Any wrongful or misleading information in the Pet Owner's Agreement may constitute a breach of terms of this Contract and be grounds for instant termination thereof.

Liability

Pets Assist Ltd accepts no liability for any breach of security or loss of or damage to the Owner's property if any other person has access to the property during the term of this agreement.

The Client, ("the legal owner") must provide the appropriate equipment, i.e, appropriate leads, collars or harnesses, pet enclosues or feeding apparatus. Pets Assist Ltd will not be held responsible or liable for any lost, stolen or broken equipment.

Pets Assist Ltd shall not be liable for any mishap of whatsoever nature which may befall a pet or caused by a pet who has unsupervised or un-secure access to the outdoors.

The Owner shall be liable for all medical expenses and damages resulting from an injury to any parties at Pets Assist Ltd caused by the dog as well as damage to the Owner's property.

Indemnification

The Owner will not blame and will reimburse Pets Assist Ltd against any and all costs, expenses, losses, liabilities and claims arising from said pet(s) behaviour unless Pets Assist Ltd are deemed willful or negligentful by law

Emergencies

In the event of an emergency, Pets Assist Ltd shall contact the Owner using the numbers provided to confirm the Owner's choice of action. If the Owner cannot be reached timeously, Pets Assist Ltd are authorised to:

- 1. Carry out Emergency Canine first aid (where applicable), where prior consent was given
- 2. Transport the pet(s) to the listed veterinarian;

- 3. Request on-site treatment from a veterinarian;
- 4. Transport the pet(s) to an emergency clinic if the previous two options are not feasible.

Security

Pets Assist Ltd warrants to keep safe Client personal information confidential. Personal information will NOT be shared with 3rd parties unless otherwise agreed in writting from the Client ("Legal Owner"). Property keys, remote control entry devices, access codes will be kept secure at all times. The Client can request personal information be removed at the end of the contract or in writing with an early termination request from the Client at any time. Keys, security devices will be returned at the end of the contract or upon the Clients written instruction for early termination.

Whole Agreement

This Contract, the Pet Owner's Agreement and Veterinary Release declaration form constitute the sole and entire agreement between the parties with regard to the subject matter hereof and the parties waive the right to rely on any alleged expressed or implied provision not contained therein. Any alteration to this agreement must be in writing and signed by both parties.

Assignment

No party may assign any of its rights or delegate or assign any of its obligations in terms of this Contract without the prior written consent of the other party, except where otherwise stated.

Walking dogs off lead

If agreed to by the Client ("Legal Owner"), Pets Assist Ltd has permission to walk dog(s) off lead. By doing so, Pets Assist Ltd agrees to only walk the dog(s) off lead at safe and appropriate times and places.

There maybe times where Pets Assist Ltd can not perform the service due to unforeseen circumstances arising from illness, adverse weather conditions or when it is unsafe to do so. Pets Assist Ltd will provide as much notice as possible, and where necessary reimburse any advanced payments or, reschedule at the discretion Pets Assist. Pets Assist will not be held liable for any breach of contract in these circumstances.
